Employer Benefits

People with disabilities are an untapped talent pool with a wide variety of skills. Employers report a great return on investment when they employ individuals with disabilities.

Reasons to Hire Someone with a Disability:

- Most accommodations for employees with disabilities cost nothing, and those that do, typically cost around \$500 (Job Accommodation Network, 2014)
- In Florida, the cost of workplace accommodations may be covered by Vocational Rehabilitation
- Employees with disabilities stay on the job longer than employees without disabilities, reducing hiring and training costs (Employer Assistance and Resource Network, 2015)
- Worker's Compensation costs are based solely on the type of business operations and loss history, and not on the demographics of employees (Employer Assistance and Resource Network, 2015)
